Complete all sections on this application and return it, along with **ALL** required documentation, to the attention of Local Union 380 Scholarship Committee ***no later than:***

July 31, 2010– If applying for both Fall 2010 & Spring Semesters

December 16, 2010– If applying for the Spring Semester ONLY

Please do not mail until you have ALL supporting documents and the package is complete.

Clarification Of Items:

- (D) College transcripts submitted must be official and should contain **ALL** years including the Spring semester.
- (G) You must return the certificate of enrollment form (attached) filled out by the school Admission/Registrar's office OR submit a formal letter from the school stating that you are registered as a full time student (full time being at least 12 credits per semester) for the Fall 2010 semester **OR** Spring semester.
- (H) Please have them include the number of credits you are registered for.

Be sure to sign and date your application.

IMPORTANT NOTES:

1. Applicant must be:
 - a child of an **active** member **or**
 - a child of a permanently disabled member **or**
 - approved for this scholarship prior to active member retiring
 - a legally adopted child of an active member
 - a child of a member who passed away during active membership
 - Under the age of 25(Please note: Step-child of an active member (will qualify for a 50% scholarship))
2. Applicant must be a full time student (12 or more credits per semester).
3. Applicant must have a 2.0 GPA or higher to be eligible for renewal.
4. Please be sure to notify the Scholarship Committee in writing of any changes which may occur, ie: Change of school, change of major, etc. The scholarship cannot be awarded unless all information is correct.
5. Scholarship, when awarded, will be paid jointly to the school and student. No exceptions.
6. Scholarships are partial, for one year, and not automatically renewed.

IMPORTANT -- Any applicant failing to comply with any or all of the above instructions within the required time will lose his/her opportunity for consideration of a scholarship award.
